## Notification by Members of Workington Town Council of pecuniary and other registerable interests.

*Localism Act 2011, Sections 28 and 29; The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012*

To comply with the Town Council's Code of Conduct, a Member or Co-opted Member must register their pecuniary and interests other than pecuniary interests with the Council's Monitoring Officer within 28 days of the date of their election or co-option. Failure to declare a disclosable pecuniary interest is a criminal offence.

### Disclosable Pecuniary Interests

These are interests if it is of a description specified in regulations made by the Secretary of State, and either it is in your interest or your partner's (which means spouse or civil partner, a person with whom you are living as husband or wife, or a person with whom you are living as if you are civil partners) within the following descriptions.
