Notification by Members of Workington Town Council of pecuniary and other registerable interests.

Localism Act 2011, Sections 28 and 29; The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012

To comply with the Town Council's Code of Conduct, a Member or Co-opted Member must register their pecuniary and interests other than pecuniary interests with the Council's Monitoring Officer within 28 days of the date of their election or co-option.
