This document is now subject to Independent Examination. I am the Programme Officer assisting the Inspector with all aspects of the Examination.

The Secretary of State has appointed Inspector Susan Holland MA DipTP MRTPI DipPollCon of the Planning Inspectorate to conduct the Examination.
