Notification by Members of Workington Town Council of pecuniary and other registerable interests.

Localism Act 2011, Sections 28 and 29; The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012

To comply with the Town Council's Code of Conduct, a Member or Co-opted Member must register their pecuniary and interests other than pecuniary interests with the Council's Monitoring Officer within 28 days of the date of their election or co-option. Failure to declare a disclosable pecuniary interest is a criminal offence.

If in doubt about whether or not something should be declared, you are urged to err on the side of openness and avoid the risk of not registering something in error.

Disclosable Pecuniary Interests

These are interests if it is of a description specified in regulations made by the Secretary of State, and either it is in your interest or your partner's (which means spouse or civil partner, a person with whom you are living as husband or wife, or a person with whom you are living as if you are civil partners) within the following descriptions.
